## What is the Kent School District Native American Education Program?

The Native American Education Program is mandated by Title VI (Part A) of the Elementary and Secondary Education Act.

The intent of this law is to provide financial assistance to school districts for the development and implementation of programs specifically designed to meet the culturally related academic needs of Native American/Alaska Native students.

#### What services are provided?

- Advocacy for Native Students and their families at the school and district levels
- Information on college and career workshops and events
- Scholarship and financial aid information for high school students
- Cultural enrichment opportunities
- Family Culture Nights held potluck style
- Parent Advisory Committee Meetings
- Speakers and presenters from the Native American Community
- Cultural field trips with emphasis on secondary learners and college prep



## Who is eligible?

Your child may be eligible to participate in the Kent School's Native American/Alaska Native Education Program. For each child who is registered on a **506** Eligibility Certification Form, the district receives Federal Title VI funding to pay for academic programming for Native American students.

In order to be counted as part of this program, a **506** form must be filled out by a parent/guardian of the Native American student.

When filling out the form, parents should list at least the child's name, the name of a US federally recognized tribe, and sign and date the form.



It is not required that a student be enrolled in a federally recognized tribe if a parent or grandparent is enrolled. There is no blood quantum requirement to enroll and participate in the program but a tribal enrollment number is preferred.

This form needs to be filled out only once for the duration of your student's time at Kent School District. We will keep all information confidential in a file at Student Services.
